- III. Approval of May Tarpon Club Minutes

IV. Treasurer's May Tarpon Club Report — Tom Hood

End of Month Cash on Hand was \$158,662. Monthly Expenses were \$8,614, which was \$1,638 under budget. For the year, we are \$5,534 under budget. Total Reserves is \$137,425, of which \$30,033 is Deferred Maintenance.

- V. President's Report Lucy Kolovos
 - A. Update on Clubhouse Closure Triad's 2nd Inspections was on June 15th and the carrier's 2nd Inspection is tomorrow, June 21st. We are awaiting written reports.
 - B. Fire Marshall Clubhouse Assessment for Occupancy by Fire Marshall was determined to be a maximum of 95 guests; sign will be posted. We were advised to remove the Exit Sign above the entrance of the kitchen and also to replace the non-functioning Exit Sign over the entrance to the Sun Room.
 - C. Maintenance Committee A "Lighting Maintenance Form" will be posted on the building Bulletin Boards for owners to use when light bulbs are seen to be out, and Board Members will take responsibility for replacing them.
